## APPLICATION INSTRUCTIONS

To apply for free and reduced price meals complete only one application for your household using the instructions below. Sign the application and return the application to 60 South 3<sup>rd</sup> Avenue, Mount Vernon, NY 10550.

If you have a foster child in your household, you may include them on your application. A separate application is no longer needed. Call the school if you need help: (914) 668-2553. # PART 1 ALL HOUSEHOLDS MUST COMPLETE STUDENT INFORMATION. DO NOT FILL OUT MORE THAN ONE APPLICATION FOR YOUR HOUSEHOLD.

- (1) Print the names of the children, including foster children, for whom you are applying on one application.
- (2) List their grade and school.
- (3) Check the box to indicate a foster child living in your household, or if you believe any child meets the description for homeless, migrant, runaway (a school staff will confirm this eligibility).

# **Letter to Parents for School Meal Programs**

## Dear Parent/Guardian:

Children need healthy meals to learn. **Amani Public Charter School** offers healthy meals every school day. Breakfast costs **\$2.20**; lunch costs **\$3.40**. Your children may qualify for free meals or for reduced price meals. Reduced price is **\$0.25** for breakfast and **\$0.25** for lunch.

- DO I NEED TO FILL OUT AN APPLICATION FOR EACH CHILD? No. Complete the application to apply for free or reduced price meals. Use one
  Free and Reduced Price School Meals Application for all students in your household. We cannot approve an application that is not complete, so be

- WHO CAN GET FREE MEALS? All children in households receiving benefits from SNAP, the Food Distribution Program on Indian Reservations

- 7. MY CHILD'S APPLICATION WAS APPROVED LAST YEAR. DO I NEED TO FILL OUT ANOTHER ONE? Yes.
